

**MINUTES**

1. Miss Kimberly O. Johnson, Board Chair, called the meeting to order at 5:15 p.m.
2. The Board paused for a moment of silence.
3. Mrs. Wilson led the Pledge of Allegiance.
4. Miss Johnson stated The Clarendon Citizen, The Manning Times and The Clarendon Sun were notified of the time, date, place and agenda of the meeting via facsimile and email. No one from the media was present.
5. Without objection, the agenda was approved.
6. No one addressed the Board during the public comment period.
7. Ms. Hettie Rutland appeared before the Board to request release of her child to attend Clarendon School District Three. No action was taken at this time.

Ms. Sadrina Edward Waringer appeared before the Board to request release of her two (2) children to attend Clarendon School District One. No action was taken at this time.

Mr. Tindal presented to the Board a letter from Mr. LeBon Joye who requested the use of Manning High School's football field for games for their youth football program during the 2018-2019 school year. He stated that they would be using the field on Monday nights and an occasional Tuesday night. After discussion, Mr. Land made a motion to approve the use of Manning High School Football Field for the Youth Football program. Mr. Moyd seconded the motion which passed unanimously.

8. At 5:25 p.m. Mr. Prince made a motion to go into Executive Session regarding Employee Matter and Recommendations/Reports on Employee Matters. Mrs. Wilson seconded the motion which passed unanimously.
9. At 6:29 p.m. Mr. Prince made a motion to come out of Executive Session. Mr. Fleming seconded the motion which passed unanimously. The following actions were taken:

Mrs. Harrington made a motion to release one (1) certified administrator from their 2018-2019 contract. Mr. Prince seconded the motion which passed with a 7 to 1 vote.

Mr. Land made a motion to approve the release of one (1) student from Clarendon School District Two to attend Clarendon School District Three for the 2018-2019 school year. Mr. Fleming seconded the motion which passed unanimously. (Ms. Hettie Rutland)

Mr. Moyd made a motion to approve the release of two (2) students from Clarendon School District Two to attend Clarendon School District One for the 2018-2019 school year. Mr. Prince seconded the motion which passed unanimously. (Mrs. Sadrina Edwards Swaringer)

Mr. Tindal presented a letter from Ms. Kirstin J. McCoon requesting to the Board to request release her children to attend Sumter County School District. After discussion, Mrs. Wilson made a motion to approve the release of two (2) students from Clarendon School District Two to attend Sumter School District for the 2018-2019 school year. Mrs. Lemon seconded the motion which passed unanimously.

10. Information from the Superintendent:

- Mr. Tindal handed out the 2018-2019 Junior Varsity and Varsity Football Schedules.
- Mr. Tindal informed the Board that the District Wide meeting will be held on August 15, 2018 at Weldon Auditorium beginning at 8:00 a.m.
- Mr. Tindal read a Thank You card from Mr. Bobby Lambert and his family, thanking the district for their support.
- Mr. Tindal also informed the Board that he (the district) is applying for another SRO position through the State Department of Education by the Legislature.
- He also said that there is some painting going on in the schools this summer.
- Mr. Tindal also said that he is recommending the following as related to the rental use of school facilities. He recommended that the Board increase the fee for personnel cost from \$150.00 to \$200.00 and only grant a request for waiver for the use of Manning Elementary School. After discussion, Mr. Land made a motion to accept the superintendent's recommendation to increase the personnel fee to \$200.00 per event and to only accept a waiver for use of facilities for the Manning Elementary School. Mr. Moyd seconded the motion which passed unanimously. Mr. Fleming recused himself from voting.
- Mr. Tindal informed the Board that due to the fact that Mrs. Sharon Miller is on medical leave, Mr. John Hilton will be filling in until she returns.
- Mr. Tindal also informed the Board that the New Teacher Orientation Luncheon will be held on Monday, August 13, 2018 at 12:00 noon at Manning Junior High School.

- Mr. Tindal also informed the Board that the Clarendon School District Two Crew will be performing at the district-wide meeting.
