1. Ms. Johnson, Board Chair, called the meeting to order at 12:00 noon.
2. The Board paused for a moment of silence.
3. Mr. Prince led the Pledge of Allegiance.
4. Ms. Johnson stated The Clarendon Citizen, The Manning Times and The Clarendon Sun were notified of the time, date, place and agenda of the meeting via facsimile and email. No one from the media was present.
5. Without objection the agenda was approved.

 - Mr. Tindal informed the Board that Mrs. Barr wanted to know who would be attending the 2019 Annual Convention in February 2019. All Board members said that they would be attending.

- Mr. Tindal reminded the Board of the events that were going on in the district at the schools during this week.
