1. Mrs. Harrington, Board Secretary, called the meeting to order at 12:00 noon.
2. The Board paused for a moment of silence.
3. Mrs. Wilson led the Pledge of Allegiance.
4. Mrs. Harrington stated The Clarendon Citizen, The Manning Times and The Clarendon Sun were notified of the time, date, place and agenda of the meeting via facsimile and email. No one from the media was present.
5. Without objection the agenda was approved.
6. No one addressed the Board during the public comment period.
7. Mr. Daishawn C. McFadden appeared before the Board to request waiver for the use of Manning High School Football Field and Gymnasium for the Clarendon Elite Youth Football Camp to be held on June 28 – 29, 2019. After discussion, Mr. Land made a motion to waive the fee and allow the Clarendon Elite Youth Football Camp to use the Manning High School Ramsey Stadium and Gymnasium for their 2019 Annual Football Camp; however, custodial fees will have to be paid and liability insurance must be provided. Mr. Prince seconded the motion which passed unanimously.
8. At 12:07 p.m. Mr. Prince made a motion to go into Executive Session for Student Hearings and Recommendations/Reports on Employee Matters. Mrs. Wilson seconded the motion which passed unanimously.
9. At 12:55 p.m. Mr. Prince made a motion to come out of Executive Session. Mrs. Sweat seconded the motion which passed unanimously. The following actions were taken:

Mr. Land made a motion for **Student A** to be suspended for 10 days with credit for days already missed and to attend the Pride Academy. Mother of **Student A** must also check his pockets and book bag each day and his phone given to his teacher or administrator every day. **Student A** must ride the bus to Manning Primary School unless mother brings him to school as a car rider. **Student A** is also placed on strict probation for the

remainder of the 2018-2019 school year. Mr. Prince seconded the motion which passed unanimously.

Mr. Prince made a motion to hire two (2) certified personnel for the 2019-2020 school year. Mr. Moyd seconded the motion which passed unanimously.

Student B was a no show.

10. Mr. John Jackson, Mr. Eddie Toler and Mr. Zack Zorndorff appeared before the Board to discuss security doors for the district which was received as information. No action was taken.
11. Information from the Superintendent:
 - Mr. Tindal informed the Board that Board Budget work session will be held on March 7, 2019 with the Superintendent and the Budget work session with the Chief Finance & Operations Officer will be held on March 26, 2019.
